- National Ocean Plan (Nat'l. Strategy for a Sustainable Ocean Economy)
- 2024-2029 Proposed Final OCS Oil & Gas Leasing Program
- Natural Capital Accounting







- Goal: Conserve 30% of U.S. waters by 2030
- Origin: Jan. 2021 Executive Order on "Tackling the Climate Crisis at Home and Abroad"
- Awaiting federal database of areas deemed already conserved
- NOPC study: 4,200+ sites covering area ~5x U.S. EEZ already conserved







ALASKA REGION

The U.S. Alaska region includes **340 marine sites** being managed for conservation and/or safety purposes, spanning over **20 million km**². That equates to **over 5 times the size of Alaska's Exclusive Economic Zone** (3,770,021 km²).¹

 A return to more normalized leasing activity is unlikely, barring congressional action and/or a new administration






Natural Capital Accounting
